Stevens Creek Corridor Master Plan & Environmental Review

The City of Cupertino launched a master planning project to look at the Stevens Creek Corridor in Spring 2014 when they hired MIG, a landscape architecture and public engagement firm, to lead the project. The Stevens Creek Corridor (SCC) Master Plan project addresses the area from Stevens Creek Boulevard south to McClellan Road. It includes the areas of McClellan Ranch Preserve, McClellan Ranch West, Blackberry Farm Park, Blackberry Farm Golf Course, Stockmeir Ranch, the Stevens Creek Corridor Trail, and associated lands.
