RECOMMENDATION

1. Waive the minor irregularity in the low bid of Jones Brothers Enterprises, Inc. of Morgan Hill.
2. Award the construction contract for the Stevens Creek Trail Pedestrian/Bicycle Overcrossing at Moffett Boulevard, Project 04-33, to Jones Brothers Enterprises, Inc. of Morgan Hill for the low bid price of \$3,362,940.

FISCAL IMPACT

Stevens Creek Trail Pedestrian/Bicycle Overcrossing at Moffett Boulevard, Project 04-33, is funded in the amount of \$4,900,000 from the Shoreline Community Fund. The estimated total project cost based on the low bid is \$4,757,000.

BACKGROUND AND ANALYSIS

On October 23, 2007, the City Council approved the plans and specifications for the Stevens Creek Trail Pedestrian/Bicycle Overcrossing at Moffett Boulevard, Project 04-33, and authorized staff to advertise the project for bids. On April 3, 2008, seven (7) bids for the project were received, ranging from \$3,362,940 to \$4,425,940 (Attachment 1). The low bid was received from Jones Brothers Enterprises, Inc. of Morgan Hill. Jones Brothers made an arithmetic error in totaling the submitted bid of \$3,353,641. The actual bid, based on a correct summation of bid items, is \$3,362,940. With the correct arithmetic, Jones Brothers is still the low bidder and staff recommends waiving the minor irregularity and awarding the contract based on the correct total. This bid is approximately 9 percent below the Engineer's Estimate of \$3,700,000.

Based on the low price bid, the estimated cost of the project is as follows:

Construction of the project is scheduled to begin in May 2008 and should be completed by March 2009. In accordance with the California Environmental Quality Act (CEQA), the City Council approved a Mitigated Negative Declaration of Environmental Impact for the project on May 8, 2007.


