RECOMMENDATION

1. Adopt A RESOLUTION APPROVING THE APPLICATION FOR GRANT FUNDS FOR THE TRAILS AND OPEN SPACE GRANT PROGRAM UNDER THE CLEAN, SAFE CREEKS AND NATURAL FLOOD PROTECTION PROGRAM OF 2000 FOR STEVENS CREEK TRAIL FROM SLEEPER AVENUE TO DALE AVENUE AND HEATHERSTONE WAY, to be read in title only, further reading waived.
2. Adopt A RESOLUTION APPROVING THE APPLICATION FOR GRANT FUNDS FOR THE TRAILS AND OPEN SPACE GRANT PROGRAM UNDER THE CLEAN, SAFE CREEKS AND NATURAL FLOOD PROTECTION PROGRAM OF 2000 FOR PERMANENTE CREEK PEDESTRIAN/BICYCLE OVERCROSSING AT HIGHWAY 101, to be read in title only, further reading waived.

FISCAL IMPACT

Stevens Creek Trail, Sleeper to Dale/Heatherstone, Construction, Project 10-42, is funded in the amount of \$5 million from various City funds and State grants. If received, the additional grant funding of \$145,000 would supplement existing project funding.

Permanente Creek Pedestrian/Bicycle Overcrossing at Highway 101, Construction, Project 06-33, is funded with \$8,250,000 from the Shoreline Community Fund. If received, the additional grant funding of \$125,000 would supplement existing project funding.

BACKGROUND AND ANALYSIS

The SCVWD has issued a Request for Project Proposals for the Trails and Open Space Grant Program under the Clean, Safe Creeks and Natural Flood Protection Program of 2000. There is approximately \$1 million available for grant awards this year. The grants are competitive, and staff expects the available funding to be divided among multiple agencies and projects.

The objectives of the grant program include: (1) providing public access to trails along creeks and open space; (2) increase community recreational opportunities; (3) increase the number of bicycle paths for alternative transportation; and (4) provide opportunities to incorporate trails, open space and parks into flood-protection projects.



The Stevens Creek Trail, Sleeper to Dale/Heatherstone, and Permanente Creek Trail Overcrossing of Highway 101 are the only City projects that fulfill the grant objectives and meet the project eligibility requirements of the program. Staff tailored the grant funding requests, including projects and funding amounts requested, to maximize the chances of receiving grant awards based on the information available from the SCVWD.

Grant applications are due March 1, 2010, and must be accompanied by a resolution authorizing the City to apply for the grant and certifying that the City has, or will have, sufficient funds to operate and maintain the project.




